Dear colleagues,

As the pandemic continues, OTF recognizes the stress that education workers are feeling as they try to provide a quality education experience for students while keeping their health and safety at the top of the list. Education workers should be prioritized for vaccinations if the Ford government is, indeed, committed to a return to school plan that is safe and sustainable.

OTF continues to recognize disturbing trends in the policies and practices the Ministry of Education and the Ford government are putting in place. The direction certainly points to a shift to privatization of our publicly funded education system. This is unacceptable. Strong, publicly funded education provides opportunities for success for the children and families

of Ontario without barriers based on cost or equitable access. OTF has been involved in an active campaign pushing back on these disturbing trends. Social media messaging has been used to educate our members and the Ontario public. Also, we have used our interactions with other education stakeholders to express our concern regarding these trends and advocate for appropriate funding for the publicly funded education system. Finally, opportunities for research partnerships are being sought out to investigate the impact of online learning on the learning outcomes of students and how these trends fit into the publicly funded education system.

As we head into the final third of the school year, OTF will continue to work on behalf of our members to protect publicly funded education in Ontario and to support the educators who work every day to help students learn as well as deal with the challenging times that our communities are facing.

We ask that all educators be sure to take care of their own wellbeing and seek out support if they need help.

Creating conditions, conversations and collaboration for equity, diversity and inclusion in teacher education



Each year, OTF and the Affiliates co-sponsor a conference on teacher education to discuss current trends and issues in preservice teacher education. Participants include liaison officers who sit on our Teacher Education Liaison Committees (TELCs) at the 13 faculties of education in Ontario, along with faculty members and teacher candidates. Both last year and this year, the event was combined with the annual retreat of the OTF Curriculum Forum, an assembly of some 50 Ontario subject and division associations.

This year's symposium, *Creating conditions, conversations and collaboration for equity, diversity and inclusion in teacher education*, was held on February 5-6 and due to COVID-19 restrictions, was fully online.

A tremendous success, the symposium provided an important opportunity for the 144 participants to take a critical look at work currently being done to promote equity, diversity and inclusion in education. Our four exceptional keynote speakers (Rania El Mugammar, Jodie Williams, Giidaakunadaad (Nancy) Rowe and Darlene Ciuffetelli Parker) delivered on their promise to push our learning deeper. They helped us see how we can move from intention to action and how we can transition from being concerned observers to agents of real and lasting change. Workshops were presented by ETFO, OSSTF, le Centre ontarien de prevention des agressions (COPA), the Canadian Museum of Human Rights and our Indigenous partners at the First Nations, Métis and Inuit Education Association of Ontario (FNMIEAO). Finally, all participants were asked to commit to doing at least one thing differently after the symposium was over, so that what they had learned and achieved would not be lost.

Lost and found pensions

Every year, teachers leave the profession before they reach retirement. When they leave, they often leave behind their contributions to the Ontario Teachers' Pension Plan (OTPP). An eligible Plan member must be 50 years old to receive a pension, but a Plan member



who leaves teaching does not have to wait until they turn 50 to take advantage of the assets they have accumulated in the Plan.

If you know someone who taught for a time and then left the profession, encourage them to contact the OTPP to investigate what options may be available to them.

Regardless, it is always good practice for all Plan members to contact OTPP to make sure their current contact information is up to date.

Dear colleagues,

As we head into spring and the remainder of the school year, it is hard to ignore the challenges endured by Ontario's teachers, educators and students during the past 12 months, including the cycle of school closure and reopening that has occurred across the province.

Through it all, teachers and educators have done their utmost to adjust to these challenging circumstances, despite the lack of proper support from the Ontario government, in an effort to keep students engaged, learning and progressing on their own educational journeys.

At OTF, we are so proud of what Ontario's teachers and educators have been able to accomplish in the face of adversity and despite what they have had to put up with from the Ford government: inadequate funding for our schools, health and safety protocols that ignored the advice of health experts, inconsistent and self-serving messaging, and a continuing fixation on online learning that doesn't work for most students.

And we are also proud of our Affiliates – AEFO, ETFO, OECTA, OSSTF – for regularly calling out the current government for its ongoing failings to the teachers, educators and students of this province.

The March 24th Budget is but another example of this government's unwillingness to properly invest in education on behalf of the students of Ontario.

In the meantime, we continue to advocate against the unnecessary imposition of EQAO testing at the secondary level — a pilot test of an online platform no less — a further unwanted burden on students and teachers during a school year otherwise fraught with unprecedented challenges.
