## Two new Directors appointed to Teachers' Board

**Mr. Hodgson** has extensive corporate governance experience. He has held the Investment and Risk Committee Chair role at PSP Investments, the board Chair roles at large companies, including Hydro One and the New Securities Self-Regulatory Organization of Canada. He had a global career with Goldman Sachs, followed by founding his own alternative investing firm. He brings deep expertise in private markets investing, valuations, and risk management. Mr. Hodgson devotes significant time to public sector / industry causes, leveraging his private sector expertise to contribute to the public sector. He is a strong supporter of Canadian veterans and a champion for diversity groups. Mr. Hodgson holds a bachelor's degree from the University of Manitoba, an M.B.A. from the Ivey Business School, and the FCPA as well as the ICD.D designations.
